1. Call to Order

The meeting was held via Zoom and called to order at 4:00 p.m. by Chairperson Ernest Lamphere.

2. Additions to Agenda:

Clerk took roll call of Zoom participants.

3. Checklist Additions:

Informational and no vote required.

4. Checklist Removals:

Char Osterlund moved to accept the list of removals presented. Motion seconded by Warren Cross. No discussion. Motion passed.

5. Appointment of Poll Workers:

a. Request of Clerk to appoint additional poll workers as needed:

Mark Greenvall moved to accept the poll worker assignments presented (see attached) and to allow the Clerk to appoint additional poll workers as needed. Motion seconded by Rick Hunter. No discussion. Motion passed.

6. Appointment of Justices to deliver ballots to physically disabled voters as soon as Absentees become available (17 VSA 2538):

Town Clerk notified board of the Secretary of State's guidance that the BCA only need to provide the service of JP delivery "if a town or city has two Justices of the Peace that re willing, able, and available..." Further that "Justices of the Peace performing this service are not required to enter the home and must be allowed to observe the voting process as is required of tem from a safe distance outside the home. Justices may be unable to perform this service if the voter is located in a hospital or other health care or long-term care facility..."

Chuck Gregory and Char Osterlund volunteered to be appointed for JP delivery. Warren Cross motioned and Rick Hunter seconded to appoint Chuck Gregory and Char Osterlund. No discussion. Motion passed.

7. Public Comment

Town Clerk notified the board of the Secretary of State's guidance allowing for the processing of early tabulator processing of ballots. This process was performed today by Warren Cross, Kathleen Stankevich and Mark Greenvall and will be done again on August 6, 2020. Discussion ensued regarding what makes a ballot defective and how many defectives we currently have received back and how many ballots were processed today. Discussion ensued regarding the difficulty voters may have understanding the absentee Primary voting process despite the instructions contained within each absentee ballot mailing as well as the total participation rate in prior years.
